One more signature is still needed for the LEOP and then will begin distributing. Saline County - The remodeling of the courthouse is getting close to completion. The EOC in the basement is just about finished. A lot of work and time has been put into the project that will increase the security.
- D. William McPherson, Thayer County There have been no hazmat issues. The LEOP is completed and are starting to have it adopted by the communities. The last storm did cause some flooding. There has been a new stream gauge added on the Little Blue and Rose Creek that will help better predict and warn about flooding.

# 9. Training / Education Presenation

Mark Meints gave a presentation regarding the planning that has been done for the August 21, 2017 solar eclipse. It is anticipated that approximately 50,000 people will come to the area to see the eclipse. The Beatrice Homestead is making plans for 20,000 to be on-site. A lot of the communities in the area have local events planned for the weekend. A question was posed if the media will need to be credentialed to get into the Homestead if at capacity and what do you want the role of media to be with the pre-planning and during the eclipse. NEMA has also been working with several other counties to help with their preparedness activities.
